YOUR CAR ON VIDEO

One of the many advantages Teslas offers is surveillance. As revealed by *Wham Baam Teslacam* on YouTube and Facebook, many recorded events involve audaciously stupid acts or even malicious vandalism. If you need to file a report with the police, offer the video to them before posting on social media. If posting could compromise law enforcement efforts, wait until given the all-clear. (If you do submit to *Wham Baam Teslacam*, we encourage you to identify yourself as a member of our club. Tell us, too, so we can alert our membership to your video.)

As Neil Mazer discovered driving north on I-15 just before the Temecula Parkway exit, Tesla's honk-to-record feature was instrumental in proving a gravel truck was sprinkling rocks in its wake. Unfortunately, as the photo shows, that damage was substantial.

Not only was his new Tesla in the shop for six weeks, it cost \$10,000 because Tesla repairs and multi-sensor parts are more elaborate than for the average car. The windshield, for instance, had to be ordered from Fremont, California and took almost three weeks to arrive. Then it arrived cracked and had to be reordered with another two-week delay.



Neil honked to capture the whole event and, by transferring the video to the free program VLC media player, he froze the moment as one pebble hit the windshield. His insurance company happily received the videos and photo to link the incident to the gravel company, so they paid for the damage. By the way, that gravel company is located in Lake Elsinore, so it sends trucks up and down the freeways in our county.

TOP PERFORMANCE

Tesla clubs are qualified at one of three levels: Chill, Performance, and Plaid.

Tesla Owners Club of Riverside County sped past Chill and into Performance stage. (There are no Plaid clubs yet.)
