

Transparency

This may seem a subtle point of distinction, but clubs differ in the way they accept and handle funds. The leaders of your club want you to know their firm policy about transparency.

We operate as a nonprofit and are officially a 401(c)3.

The club was not organized with a profit motive but instead strictly for the benefit of members and the community. We will try to operate so the club will never need to have membership dues.

Leaders are volunteers, so they will never be paid for their time and skills. Some costs are associated with the club, however, such as \$350 per year for insurance, \$300 for set-up costs (incorporation, non-profit), etc.

In time, when we sell advertising or merchandise, all profit will go directly to the club to pay down some of those costs.

To track expenditures, our members with a valid VIN and an email address have access to all filings on our website, including financial statements (income statement and balance sheet).


July 25, 2021
